Featured School Houston Community College @ Houston, Texas



Houston Community College (HCC) in Houston, Texas began truck-driver training in 1995 with one tractor and one trailer. Today, it has expanded to include 24 tractors, 25 trailers, and it employs 13 full-time instructors, four support staff, one mechanic, and numerous part-time instructors.

The program is located at the Northeast campus of HCC. It occupies 13 acres, which includes a 13,000-square-foot building with nine classrooms, one computer lab, and an oval track 7/10th of a mile long, with a large concrete skills area for backing, docking, and parking exercises.

The day program is a 286-hour, PTDI certified program, with HCC awarded a five-year certification in December 2010. This was the third renewal with PTDI. Other programs offered include weekend classes; evening classes and several contract

training classes with both local and national companies. HCC has new open enrollment classes that begin every two weeks and contract classes that begin weekly.

Over the years, HCC has enjoyed high graduation and placement rates for its students. As the truck-driving training industry changes, HCC must constantly make changes to its curriculum in order to provide students with the best possible tools for success. HCC has witnessed many changes to its student population – and with these changes it has learned to adapt so that students are ready to begin their new career in the trucking industry. In the coming year, the school will incorporate more online activities, with new industry resources available to make this possible.

Since the program's inception, more than 10,000 HCC students have completed truck-driver training and embarked on a new career. The ability to help change a person's life and put them "on the road to success" is very rewarding for HCC instructors and staff. Many students have become successful drivers, owner operators, and fleet operators. They have experienced a positive financial impact, which gives them a new opportunity to support their family.
