There have been plenty of new things happening at Meridian Community College

The commercial truck-driving program at Meridian Community College (MCC), part of the Mississippi Junior/Community College system, is located in the east-central part of Mississippi in the city of Meridian, adjacent to Interstate highways 20 and 59. Facilities consist of a building that houses offices and classrooms and a large concrete practice pad. Otis Gowdy is the program director.

MCC's L3 Communications Truck Driving Simulator, purchased in 2005, was one of the first in the Southeast and, until recently, the only in Mississippi. Since obtaining this simulator, instructors have noticed that students are able to grasp the essentials of shifting and handling the trucks much quicker than they could before.

The simulator, while important, isn't MCC's only recent initiative. Fender-mounted video cameras (from Gearmaster) have recently been added to the tractors. Additional equipment has been updated through purchases and donations, including a tractor and trailer from an Interstate drug bust.

Staff changes have also occurred in recent years. In May 2005, Irven Skinner, the Work-Based Learning Coordinator at MCC, was moved from the main campus to the truck driver-training center to assist Mr. Gowdy. In addition, Jimmy Rigdon was hired as an instructor that fall.

Each classroom is capable of using PowerPoint and video presentations. The commercial truck-driving program consists of 8 weeks of classes in each session, with two sessions in the fall and spring semesters and one during the summer. Day and evening classes are offered, as well as an 80-hour refresher course. Students receive 12 semester hours of credit for the 8-week period.

In addition, in fall 2008 students were eligible to take an 8-week internship class. The extra 7 semester hours enable students to apply for Pell grants and Federal student loans. Currently, 10 major carriers are participating in the internship phase of the course. The interns are employees of the company and receive the same pay and benefits as other student drivers.

In addition to CDL classes and refresher courses, the program also offers forklift safety training and fleet safety classes. Moreover, two MCC instructors are certified by the Mississippi Department of Public Safety to administer the skills portion of the Mississippi Commercial Drivers License exam.

MCC students also received realworld training immediately following Hurricane Katrina. The Mississippi Trucking Association requested assistance from MCC to move relief supplies from the central warehouse in Jackson to affected areas along the Gulf Coast. Classes had just started and continued throughout the relief effort. Students received classroom instruction each morning, and then traveled to Jackson to pick up supplies to deliver that afternoon and evening. This effort went on for several weeks. Eagle Express and MCC even delivered hay donated by farmers in Mississippi and Alabama. As stated, this was unique training not offered in classrooms!

Finally, the MCC commercial truck-driving program is a "Professional Truck Driving Program" and a proud member of the NAPFTDS.

☐ ASSOCIATE MEMBERSH P (\$350): Any industry or representative employee of that industry which indirectly supports public truck driving schools, limited to agencies such as trucking companies, insurance companies, publishers, and equipment manufacturers interested in the welfare of publicly funded truck driving schools.

☐ AFFILIATE MEMBERSHIP (\$250): Limited to administrators or staff at a publicly funded school interested in the trucking industry or administrators in schools that contract with proprietary organizations to provide truck driver training.

THE NEXT STEP: Application for membership shall be made on an application form as may be required by the Board of Directors. A majority vote of the Board of Directors is necessary for the acceptance of an application for membership. All applicants who have been accepted into the membership of the Association must submit a fully completed and signed application form that, by doing, signifies their adherence of the Articles of Incorporation and Bylaws of said Association. Jet Express Donates Tractor to School

The Ohio-based Clark State
Community College recently
received a pleasant surprise when
Kevin Burch, president of Jet
Express, Inc., and chairman of the
Truckload Carriers Association,
personally drove a used tractor to
the school's "practice course." He
turned over the title and keys to the
school for use as part of its
Commercial Transportation
Training Center (CTTC).

"2009 has been a challenging time for all companies, industries and even for us 'truckers' this year," said Burch, who obtained his Commercial Drivers License last summer after taking a five-week training course at Clark State. "This is just a small way of helping the college teach our future men and

women to become professional truck drivers."

Burch added that he hopes the publicity generated from the donation of the tractor will also help to heighten interest and awareness of the job opportunities available within the trucking industry, especially for potential drivers in Ohio.

Thomas Hicswa Jr., director of Clark State's CTTC, said, "This donation will enhance the CTTC program and provide the opportunity for students to be trained on a smaller student-to-instructor ratio, which will allow for more behind-the-wheel time."

Clark State Community College's CTTC has been training entry-level drivers for class "A" and "B" Commercial Driver's



Licenses for the past 21 years. It currently trains between 150 and 200 students per year in a 184-hour program that covers safe driving practices, log books and hours of service, trip planning, and more. For more information, visit the CTTC website at www.clarkstate.edu/truck_driving.php.

Uniform CDL Standards Among Ideas Being Proposed

The American Trucking
Association recently released an 18point plan to reduce truck-involved
crashes. The ATA is calling on
Congress and the Department of
Transportation to support this plan.
One point of interest to schools proposed by ATA is a formation of uniform commercial driver licensing
standards and a study of a graduated
licensing program for entry-level
drivers.

I think we all agree that licensing standards are needed. In my travels around the country I have seen the many different CDL tests that each state has. When the CDL was put into place back in the early 1990s we all thought this was going to be a uniform test. That has not happened. Some states do not even rec-

ognize another state's test. For instance, if someone wants to transfer their license due to relocation, some states require that person to retake the CDL. This especially happens to entry-level drivers that may have been trained in a different state. When they go back home to transfer they have to retake the test. This makes no sense. If uniform standards were in place each state would recognize the other.

The graduated license idea has been out there for quite some time. In the mid-to-late 90s the TCA proposed a plan for a pilot program to train younger drivers and use the graduated license as part of this program. The Federal government (FMCSA) turned this idea down and said they would not allow a pilot



program. Their issue was safety and using younger drivers (under 21).

Now, the ATA is proposing the concept of the graduated license again. I have mixed emotions on this issue. It is a good idea to gradually introduce a new driver to the profession. However, it can also cause some restrictions to the new driver that may limit the ability to be employed — and if employed by a carrier it may also reduce income until the driver has reached full license status. I have other issues. both good and bad, but will have to discuss later. I applaud ATA on their concern for safety and their 18point plan. We must now wait on Congress and DOT to act. As we all know, that may be a long wait!
